## The Consignor and Bee and Buttafly agree to the following terms:

The Consignor warrants that all items consigned are 100% authentic. In the event that an item is found to be counterfeit, the Consignor agrees to fully refund any payments received and will be liable for a penalty of \$100 per item.

If the Consignor fails to claim their item(s) within sixty (60) days of confirmation to withdraw, Bee and Buttafly reserves the right to dispose of the item(s).

Bee and Buttafly reserves the right to request additional proof of authenticity for any consigned item. If required, the Consignor agrees to provide an Entrupy Authentication Certificate or similar documentation. If Bee and Buttafly provides this authentication service, the Consignor agrees to pay a non-refundable authentication fee of \$50 for most items or \$150 for Hermes bags, regardless of the result. If the item is determined to be counterfeit or unverifiable, an additional \$50 penalty will apply.

The final agreed-upon price for each item, as communicated via email, text, or messaging apps (such as WhatsApp, Viber, etc.), will take precedence over any price written on the Consignment Form

The Consignor will receive payment within 7 to 14 days after the item has been sold to a buyer. However, the Consignor acknowledges that delays in shipment or payment may occur due to external factors such as shipping outside certain areas.

Bee and Buttafly is not obligated to update the Consignor on the status of their items (e.g., listing date, sale date) except when payment has been processed or a withdrawal request has been initiated

The Consignor agrees not to withdraw their item for at least thirty (30) days after it has been listed on Bee and Buttafly's platform. If the Consignor wishes to withdraw an item before the consignment period ends, a \$100 fee per item will be applied. The contract remains active until the withdrawal fee is paid and the item is physically removed.

If the item remains unsold after 30 days, the Consignor agrees to reduce the item's price by at least 15% if they wish to put it on sale. Bee and Buttafly reserves the right to accept or decline the

request based on the item's marketability. Bee and Buttafly will take all reasonable care in handling and storing consigned items. However, it will not be held liable for damages caused by natural wear and tear, aging, or external factors such as weather, mold, or discoloration. In the event that Bee and Buttafly is responsible for damage, the liability is capped at 10% of the agreed consignment price.

Bee and Buttafly will not be liable for damages due to force majeure events such as fire, flood, earthquakes, or other unforeseen circumstances beyond its control.

Both Parties agree to these terms, as well as the detailed consignment terms outlined in the Consignment Agreement (Annex A).
